Arbitration will take place in Rhode Island, unless otherwise agreed by both parties in writing.

These Terms and any disputes arising under them shall be governed exclusively by the laws of the State of Rhode Island and applicable U.S. federal law, including the Federal Arbitration Act, without regard to conflict-of-law principles.
